Calculating your monthly pre-authorized giving

To help determine the amount of one's monthly contribution, multiply your weekly offering by the 52 weeks in a year, then divide this annual contribution by 12. Examples are provided below for your reference.


Note that the amounts above are provided only for example. Our hope is that parishioners will contribute an offering that is meaningful, sacrificial, and that honours the abundance with which the Lord has blessed each of us.

How will pre-authorized giving replace my current giving?

While your offering will be transferred electronically, the parish will continue to provide envelopes to those who enroll in pre-authorized giving. These envelopes can still be placed into the collection as a sign of the pre-authorized gift you are giving to the parish. Please note that special collections (i.e. Share Lent, Seminary Education, etc.) still require that offerings be placed into special envelopes, and will not be processed through pre-authorized giving.

What is pre-authorized giving?

To accomplish the mission entrusted to us by Christ, St. Teresa of Avila Parish depends entirely on the generosity of our parishioners. Pre-authorized giving allows you to give to your parish intentionally and faithfully through scheduled monthly transfers from your bank account. On or near the 20th day of each month, your account will be debited an amount you specify. These funds are then deposited directly into the parish's account.

How do I enroll?

First, reflect on all that God has given you, and prayerfully decide how much of this you will return to God through your offering to your parish. Then fill out the form on the other side of this brochure and attach a void cheque in the space provided. Place the completed form in a sealed envelope into the offertory collection, mail the completed form to the parish, or drop it off in person.
